Special thanks must go to John Beasley who created the first drafts of this 43-page epic and carried out the calculations of excess vehicle emissions expected from the creation of ratruns. Thanks are also due to many others who contributed by carrying out research, standing out in the cold doing traffic surveys, poring over documents on the internet, attending numerous meetings with councillors and officials, assisting with editing and polishing the final document and delivering the Newsletters. Not least we are grateful for the many letters and ideas we received from residents which helped us to shape the report.

We now have to wait until the first week of June for the City Deal officers to analyse the feedback and give their recommendations following the Milton Road consultations – so watch this space.

In the meantime we can use the opportunity to establish a formal constitution for the Residents' Association and hold an election for committee members and officers. Accordingly we are planning to hold an AGM in April when we will be asking for your approval to

adopt the constitution, and then your interim committee will be standing down. However I'm pleased to report that they have all agreed to offer themselves for re-election. ## So, What's Next?

Well, we can't relax too much.

There are more City Deal consultations coming out for other parts of Cambridge and, although they are not directly connected with our locality they could impact on the way we travel in the future.

The latest one is the Western Orbital link to enable buses to have priority lanes between junctions 11, 12 and 13 on the M11, or a new busway corridor to the east or west of the M11. This would be combined with new Park and Ride sites at one or more of those junctions.

As this is outside our area and remit for HPERA we do not plan to make a collective submission to the consultation, but those who are interested can find details at www.gccitydeal.co.uk/western-orbital and anyone can make an individual response. A number of drop-in exhibitions will be available but they are mostly centred around the villages to the south and west of the city. The nearest one for us will be at Lucy Cavendish College, Lady Margaret Road on Tuesday 8<sup>th</sup> March at 5.00-8.00pm.

Tuesday 8<sup>th</sup> March is also the deadline for consultation on the Milton Road Library **Development**.
