

## City Deal - where are we now?

Hardly a day goes by without an article or letter appearing in the Cambridge News pointing to the huge impact that City Deal proposals are going to have on residents and businesses across our city. Much of that publicity and awareness has been sparked by the efforts of local residents' associations, Smarter Cambridge Transport and the Federation of Cambridge Residents' Associations (FeCRA):

The Milton Road Trees & Verges Petition which now has over 4000 signatures was presented and debated in a full session of the County Council in July. It gained support from councillors across the county who voted for it to be considered once again by the City Deal Assembly and Board asking them for a commitment to retain or re-plant an avenue of mature trees in grass verges.

Resolutions were also sponsored by HPERA, MRRA and OCRA (Old Chesterton RA) calling for double bus-lanes to be removed from the Milton Road plans, and for a firm of independent urban architects to be appointed by the City Deal team. These were voted on and passed unanimously at the Local Liaison Forum last month.

When these initiatives were presented and debated at the City Deal Executive meeting at the beginning of September the three voting members of the Board failed to agree a common position on any of them. All they could come up with was a commitment to give us an answer in writing in 2-3 weeks. Not very decisive and not very encouraging!

## Where next?

We are not going to give up on this and have agreed to continue engaging with the formal consultation process through the Local Liaison Forum meetings. We have made it very clear to the Joint Assembly and the Executive Board that we have grave reservations about our association with the Local Liaison Forum as we don't wish our involvement to be misinterpreted as showing approval or endorsement of the City Deal plans.

We will be attending a series of six workshops on design details of the Milton Road plans commencing on 20th September. However, if we get a totally unsatisfactory response from the City Deal Board, then we will have to review our strategy and consider whether there are alternative options for us to pursue.
